# THRIVE

### **CAMP OVERVIEW**

#### **2024 CAMP THEME: REACH NEW HEIGHTS**

THRIVE Camps offers a variety of advanced and energetic training, instruction, choreography, and wellness components in a fun, safe, and energetic environment. Our goal is to provide you with the utmost quality, service, and support to help your team get a head start on a great season! Please see the **official camp**brochure for more information on the different formats of our camp programs.

#### **CAMP POLICIES**

#### **Attendance**

- All participating teams must be in attendance and on-time to all camp functions and activities.
- Some participants may opt to use group transportation options or to reside in a hotel or campus residence hall for the duration of camp. THRIVE is not responsible for any transportation or lodging-related incidents of our participants including at Overnight Camps.

#### **Conduct**

- Bullying, initiations, or hazing of any type are prohibited from camps. Violation of this policy may result in immediate dismissal from the camp.
- The use of illegal substances, smoking, and vaping are prohibited. Fireworks, guns, and other weapons are also prohibited. Violation of this policy may result in immediate dismissal from the camp.
- The use of cameras, imaging, and digital devices by adults and/or minors is permitted only in areas where privacy is not expected.
- Signs and banners should not be hung without permission from THRIVE Camp Administration.
- Participants may not wear jewelry of ANY kind at any time during camp.
- Virtual Camps: Participants of virtual camp services must also abide by these policies, must be in proper attire, and must take place in a location that limits the visibility of other virtual participants.
   Participants must also agree not to record, screen shot, or engage in inappropriate chat conversations with other members in a way that would be harmful or dangerous to another participant.

#### **CAMP POLICIES**

#### **INFECTIOUS DISEASE SAFETY PROTOCOLS**

#### Safety Measures to Protect Against the Spread of Infectious Diseases

- All camps booked this year will take place ONLY if current, official government mandates and public health recommendations support and allow its operations.
- Due to the ongoing risk of transmission of infectious diseases, participants may be subject to participate in a temperature check if they are showing symptoms of illness. *Those who have a temperature above* 100.4°F will be directed to be tested for respiratory and infectious diseases, and they will not be permitted to attend camp until they obtain a negative test result. Participants will also receive disinfectant items to sanitize their belongings throughout camp.
- All participants are invited to wear a mask while present at THRIVE Camps. Participants who wish to have a face covering provided while at camp may ask a camp instructor or manager.
- To assist with safely monitoring of participant symptoms in preparation for a safe camp, please see this list of updated COVID-19 Symptoms. (please see this updated list of COVID-19 Symptoms).
- Coaches or athletes who are confirmed to have tested positive for COVID-19 at least 7 days before camp are required to share this information prior to the start of camp, and will not be allowed to participate without a negative test result from a reliable testing source.
- Participants who test positive at least 5 days before camp will not be able to participate even with a
   negative test result due to the possibility of continued spread of the virus. This policy is in place for
   all participants, even those who are asymptomatic.
- Anyone who receives a positive COVID-19 test result during camp will be asked to discontinue camp
  and will receive a prorated refund for the time they will be absent, minus any included supplements
  such as recordings, virtual instruction, or materials.
- All THRIVE Staffers will abide by similar policies and will not serve as staff in camp if they exhibit symptoms of COVID-19 or flu-like symptoms or if any staffers test positive for COVID-19.
- For everyone's safety, participants are expected to respect decisions from instructors regarding physical distancing practices even if they disrupt the normally intended activities of the day.
- THRIVE will provide a 100% refund on camp fees for any canceled camps due to unexpected, uncontrollable public-health related factors, including factors related to positive cases of COVID-19 or other infectious diseases, and free date-change requests for camps that need to be postponed. These factors include positive cases on behalf of coaches or athletes, facility closures, public health restrictions, or government-level restrictions and facility or operational closures.
- For any other information about the ongoing COVID-19 pandemic, please see the updated information on the Center for Disease Control's website.

#### **CAMP POLICIES**

#### **MEALS & SUPERVISION**

#### **MEALS**

- Coaches are held responsible for ensuring all allergy or food safety considerations are communicated to THRIVE Spirit Staff at <u>all</u> camps, including both camps with THRIVE-provided meals and team-provided meals.
- Unless otherwise clarified in camp materials, lunch *is not* provided by THRIVE Spirit at our camps.
- Coaches are asked to only allow their participants to eat during the designated times and in the designated locations. Coaches and teams are responsible for keeping a clean dining area at all camps and training experiences.

#### **SUPERVISION**

- An adult at least 21 years of age is required to attend camp <u>in its entirety</u> with each team, unless a more specific policy is noted for the location. The required ratio is **1 coach per 12 athletes**.
- There will be no practice (i.e., cheering, chanting, stunting, tumbling, or dancing) allowed in areas not specifically designated for instructional classes and practice or without the proper supervision of a THRIVE instructor or coach/sponsor.
- THRIVE is not responsible for lost or stolen items. Valuables should be left at home or stored safely with a trusted supervisor.
- The coach/chaperone is responsible for participants outside scheduled class times (free time) including but not limited to: swimming, beach activities, cheer/dance practice outside of class time, or free time at the event site, university campus or hotel. THRIVE Spirit cannot be held liable for incidents that occur to, by, or with participants outside scheduled instructional times.
- Participants may not leave the campsite for ANY reason, unless prearranged and signed out with a THRIVE Camp Official. An official Coach/Chaperone must accompany any minor who leaves the site for any reason. THRIVE is not liable for participants when leaving the camp premises during operating hours.
- If an emergency occurs, contact the appropriate emergency number for your location and notify a member of THRIVE Camp Staff.
- A camp first responder may be present to provide immediate treatment to the participant. Liability concerns for this are addressed in the Medical and Media release forms.
- Participants who must go to a clinic or hospital should contact a THRIVE Official prior to leaving the campsite, who will then inform the camper's emergency contact person.

#### **CAMP POLICIES**

#### **MUSIC & EVALUATION**

#### **CAMP MUSIC**

- Teams may bring a routine from home for the camp showcase. Please be sure to adhere to the music policy for any self-provided music.
- Due to rules established by the USA Cheer organization, all routine music used at THRIVE Spirit events must comply with official music guidelines in order to avoid copyright infringement. All recordings mixed together in cheer and dance routines should be properly licensed. Permitted music includes mixes created by preferred providers or original music of which you own the license or rights by written agreement. #### **EVALUATION (OPTIONAL)**

- As a part of the **THRIVE Camps** commitment to develop ground-breaking programs, we may conduct evaluations of the personal experiences and outcomes of our participants.
- This evaluation is optional. You may opt-in to evaluations during your registration. If you choose to participate, more information will be provided. The evaluation may involve participation in the Coach Training program, a focus group interview, and brief assessments administered online.
- This evaluation will not affect your participation in our camps. However, we strongly encourage you to participate in the evaluation to help us improve our services.
- All evaluation participants will get a waiver for the Coach Training, and will get a percent-based discount off their overall registration fee.

#### **2024 FEE INFORMATION**

#### **TRAVEL COSTS**

- Our rates currently reflect costs for camps local to registered teams. THRIVE Spirit does the best to staff within the designated 60 mile radius, however, in cases where camps require additional travel, additional costs will be administered.
- For camps occurring outside of a 60 mile radius from our headquarters, there will be an additional travel fee added at the rate of: \$50/instructor for each additional 30 miles. For example:
  - o 60 miles one-way trip: No Additional Fees Administered
  - o 61-90 miles one-way trip: \$50 per Instructor added to camp balance
  - o 91-120 miles one-way trip: \$100 per Instructor added to camp balance
- For camps which require air travel, full cost of airfare fees will be assessed at the discretion of the THRIVE Representative after determining current airfare rates.
- For overnight private camps where THRIVE Camp staff must acquire lodging for the duration of camp, an additional travel fee will be added at the rate of: \$100/instructor/per night. For example:
  - 1 Night: \$100 per Instructor added to camp balance
  - 2 Nights: \$200 per Instructor added to camp balance

#### FEES & PAYMENT SCHEDULE

#### **2024 FEE INFORMATION**

#### **Fees & Payment Information:**

- Camp fees include daily instruction, awards, and, in some cases, include music and choreography recordings. Instruction Only fees include daily instruction and awards (unless otherwise noted).
- A **\$200 deposit** is due at the time of registration. Last chance registrations include a **\$300 deposit**. **Deposits are non-refundable.** Deposits can be transferred to a different team or group:
  - o June Camps: Book by and pay deposits by May 1
  - July Camps: Book by and pay deposits by May 15
- A \$75 camp change fee will be applied to any accounts requesting to change the dates and times of their camp after the deposit has been paid, unless a fee waiver is administered by the Camp Director. Camp changes can be made up to 6 weeks before your registered camp, unless given the approval of the Camp Director. An additional \$50 camp change fee (total: \$125) will be applied to accounts requesting to change the date less than 6 weeks prior to their originally-booked date.
- Payments may be accepted online or via mail with the completed registration forms. Major credit cards (Visa, American Express, MasterCard, and Discover) are accepted. Cashier's checks and official school or business checks are accepted on a case-by-case basis. Personal, individual, and booster club checks are not accepted. There is a 4% convenience fee applied to credit card payments.
- All JUNE camp balances are due by May 31, 2024 or 4 weeks prior to your registered camp date. All
  JULY camp balances are due by June 15, 2024 or 4 weeks prior to your registered camp date. Please
  adhere to the payment plan confirmed by your THRIVE Spirit Camp Representative.
- A \$100 late fee will be assessed for payments completed later than 4 weeks or 20 business days prior to the start of camp unless otherwise approved by the Camp Director. Camps for teams with camp balances unfulfilled within 2 weeks before the start of camp are subject to cancellation.
- Non-public health-related refund requests must be submitted in writing to the attention of the Registration
  Department within 28 days of the camp start date. Refunds will not be issued if requested later than 28
  days before the camp start date. Please allow 2-4 weeks for refunds to be processed.
- Any camps booked during the 2024 camp season will ONLY take place if adequate official government mandates, public health guidelines and venue policies are released which support and allow its operations.
- All promotional prices are subject to the stated terms. Discounted fees are applied at the time of registration, not consultations. Referral codes are automatically generated and used on the registration platform. For any technical issues, please contact <u>registration@thrivespirit.com</u> directly.
  - Early Registration Deadline for 10% off Camp Fees: March 15
  - Regular Registration Deadline: April 15
  - Last Chance Registration Deadline with a deposit of \$300: May 15

## **HOW TO REGISTER**

#### **REGISTRATION FORMS**

#### Forms:

The necessary registration forms are included in this packet and separately online. Please email us if you have a question about how to complete a form at registration@thrivespirit.com.

#### **REGISTRATION PROCESS**

- Email <a href="mailto:registration@thrivespirit.com">registration@thrivespirit.com</a> and set up a Camp Consultation with your THRIVE Representative to secure your dates, your camp schedule, and your final camp fee.
- Once you've reviewed & signed the information packet, complete the following forms:
  - General Camp Compliance Form
  - Official Team Roster (One for EACH Team)
  - Media & Medical Release Forms (One for EACH Participant)
- Visit our online registration platform:
  - Complete the online registration questionnaire
  - Upload all completed forms (compliance forms, rosters & this signed coach packet)
- Submit your **\$200 (or \$300) deposit** at the time of registration to secure your spot.
  - **Note: No mail-in registration forms will be accepted.** Registrations must be completed online. If your school/program requires payment via check, please make arrangements with your THRIVE Representative on how to remit payment.
- Remit full payment by the payment deadline to avoid any **late registration fees (\$100)**. For verified late-registration teams, please submit within 4 weeks or 20 business days prior to the start of camp.
- Submit infectious disease liability release and medical and media release forms via email or inperson by the start of camp.
  - **Note:** Registrations are not complete until ALL participants submit the completed release forms.

#### GENERAL CAMP COMPLIANCE FORM: THRIVE SPIRIT CAMPS 2024

- o Sportsmanship is the basis for all THRIVE Spirit programs. All coaches, participants and spectators must conduct themselves in an appropriate manner. All coaches are responsible for the behavior of their team(s) and spectators. Teams, coaches, and spectators representing a team may be disqualified or dismissed if behavior is deemed inappropriate or unsportsmanlike by THRIVE Spirit.
- o Camp Instructor and Camp Director decisions are FINAL.
- o All coaches, sponsors, and designated team supporters in attendance must register **prior** to the camp. Any additional coaches, sponsors, or designated team supporters registered on the day-of will be assessed an additional \$25 processing fee.
- o No additional, unregistered individuals will be allowed to enter with your team (this includes team moms, athletic trainers, etc.).
- o All participants must be in uniform at all times and coaches must display any ID Badges.
- o All teams must follow the guidelines established for their division. All teams must adhere to age/grade guidelines for the division in which they registered and must be prepared to show proof of age if questioned. No changes in division/level/size are allowed less than 7 days prior to the camp.
- o THRIVE Spirit reserves the right to add, divide, combine or delete divisions as needed per group camp to make each event as competitive as possible. THRIVE Spirit reserves the right to provide alternative flooring systems based on the number of registered participants by the camp deadline. All efforts will be made to provide the safest possible flooring options available.
- o All participants, parents, spectators, and coaches must follow all rules and guidelines as stated in all THRIVE Spirit forms and website materials, such as to adhere to infectious disease-related protective practices, including diseases such as COVID-19. THRIVE Spirit staff decisions related to infectious disease protocols and health concerns are final.
- o Teams may not participate without this form completed and signed by the head Coach or Sponsor. The Medical and Publicity Waivers of all participants must be correct, complete, and submitted **prior** to participation.
